Dear Angus Breeders of Texas,

I am proud to be representing your marketing group as sale manager for the inaugural sale of the Angus Breeders of Texas. The Sale will be held on 10/30/2021 at Mort Livestock Exchange, Canton, TX. This event will serve as a new and innovative marketing opportunity for Angus Breeders in the State of Texas and has been formed by a progressive group of breeders like yourself. The primary intention is to reach the grass roots Angus enthusiast, both purebred and commercial producers alike.

Please take some time and carefully review all the enclosed documents. There are several policies that need to be followed, and it is imperative that you fill out all the entry fees as completely and accurately as possible.

Entries are due to Schacher Auction Services by August 1, 2021 (however, we will accept them earlier and prefer that), and the preferred delivery is by mail. There is a \$150 entry fee per lot (Cow/Calf pairs are considered 1 Lot) that is to be returned with the entry forms. This entry fee will be applied to your final sale expense.

Each consignor needs to fill out one Consignor Information Form. Also, fill out a Nomination Form for each lot consigned, and make sure you sign the Nomination Form. Please make sure you provide me the registration number of the animal selling or the sire and dam of any embryos or pregnancies. For Lots of 2 to 5 Commercial Angus cross Females, please make sure you give me the Composition, Age of Females, Breeding Status and Service Bulls.

I will be organizing picture days at central locations for you to bring cattle that you would like pictured for advertising and catalog production. Mort Livestock Exchange in Canton has volunteered to provide one of these locations, and Rick Brooks, Whitney, TX has volunteered a facility as well. I will be in touch with you about dates for pictures. If you have another location in mind let me know.

I am excited to be working with the Angus Breeders of Texas to help present the inaugural sale. If you have any questions or if there is anything I can help you with, please do not hesitate to call me at 817-219-0102.

ANGUS BREEDERS OF TEXAS INAUGURAL SALE REQUIREMENTS AND INFORMATION

All live registerable animals (Commercial Females Excluded) regardless of age, must be registered with the American Angus Association at the time of entry. **No cattle will be settled** for until all paper work is complete and new owners have possession of sale cattle, unless arrangements have been agreed upon by both buying and selling parties.

Age Requirements: Bulls must be between the ages of 15 Months to 36 Months of age. Females must be younger than 7 years on the date of the sale.

Photography: As stated we will be organizing picture days to facilitate you. If you wish to submit pictures on your own, send them to: robschacher@gmail.com and they must be high resolution (At least 2 Megabytes). In addition these need to be high quality, well lighted photos, preferably taken and submitted by a professional photographer. A note here is for you to take a look at the photo and decide, would you buy this lot based on this picture? All pictures submitted are subject to approval by sale management.

Keep Footnotes to 150 words or less. Make your points as quickly and concisely as possible.

All cattle should be well presented. They must be sound, high quality cattle that are in proper body condition and in good health. Cattle with flaws, bad eyes, structural issues etc. will be eliminated from the sale. Please clip the heads and necks of cattle and have them as clean as possible.

Genetic Conditions: This sale will follow the protocol set forth by the American Angus Association (AAA) with the following additional requirement: DD policy for this sale will be as follows; any animal that is deemed to be DD Potential (DDP) will be allowed to sell only if that animal has been tested for the DD condition by an approved lab. The results of any Genetic Condition will be identified in our catalog as stated by AAA. DD Carriers will be allowed to sell.

Closer to the sale I will send Ear Tags to be attached to the Left Ear of the animal. There will also be specific arrival and check in information at that time, However, please plan to have your cattle at the sale facility on Thursday, 10/28/2021.

The sale expense for cattle selling in this sale will be figured using the following formula:

Total Expenses/Sale Gross X 100 = % Sale Expense.

Entry Fees will be applied to this expense.

SETTLEMENT: Once **all** entries have been paid for by the buyers, I will distribute proceeds to the sellers. If there are still outstanding receivables thirty (30) days after the sale, I will distribute proceeds to the sellers whose cattle have been settled for. I can not advance funds prior to these requirements being met due to regulations I must follow imposed by the USDA Packers and Stockyards Administration, so please do not ask for that favor.

LIENS: If any cattle, embryos or semen have pending liens against them from financial institutions or other entities, I am required by law to satisfy those lien holders first. I would appreciate a note from any consignors informing me of any liens against your assets being sold in this auction. Further, all storage facilities for semen and embryos will be contacted to ensure that a proper release has been given by each consignor, and that each of those facilities is willing to release embryos and semen before those consignors are paid. A simple Uniform Commercial Code search will be performed.

Each animal must have an individual health certificate, including fertility test results or pregnancy test results if applicable, issued by a veterinarian. Health certificates must meet requirements for movement within the State of Texas. The physical address where cattle will be delivered is Mort Livestock Exchange, 19281 State Hwy 64, Canton, TX 75103. All animals are required to have a unique identification accepted by the Texas Department of animal health. Accepted forms of ID include Bangs Clips for vaccinated females or state issued clips for non-vaccinated females and bulls. EID's will take the place of the State issued Clips in the near future and would be the preferred method for this sale. Talk to your veterinarian about this as there are some the State has issued to them for free.

ALL BULLS must be tested for Trichomoniasis regardless of whether the bull qualifies as a virgin bull.

All females 12 months of age and older must be pregnancy examined by a veterinarian, and results must be on the health certificate. All service sires must be registered Angus Bulls.
